

Idaho Depends on World Markets

- Exports from Idaho helped contribute to the \$2.26 trillion of U.S. goods and services exports in 2015.



Idaho goods exports in 2015


Idaho's Top 5 Export Categories

Exports Support Jobs

- Nationally, U.S. jobs supported by exports reached an estimated 11.5 million in 2015, up 1.9 million from 2009.

Exports Sustain Thousands of Idaho Businesses



- A total of 1,816 companies exported from Idaho locations in 2014.

...and **27%** of known Idaho goods export value







Number of Employees by Country of UBO





Free Trade Agreements


- The U.S. currently has 14 free trade agreements in force with 20 countries.
- Idaho's exports to U.S. FTA partners totaled \$2 billion in 2015.

In 2015, exports to FTA markets accounted for **47%** of Idaho exports



Since 2005, exports from Idaho to FTA markets have grown by **79%**

Idaho's Metropolitan Exports

- Boise City is the 85th largest metro area reporting goods exports nationwide.

| Metro Area | 2015 Goods Export Value | Share of State Exports |
|---------------|-------------------------|------------------------|
| Boise City | \$2.7 billion | 62.6% |
| Logan | \$453 million | * |
| Idaho Falls | \$308 million | 7.2% |
| Coeur d'Alene | \$203 million | 4.8% |
| Pocatello | \$199 million | 4.7% |
| Lewiston | \$99 million | * |
