
## Missouri Depends on World Markets

- Exports from Missouri helped contribute to the \$2.26 trillion of U.S. goods and services exports in 2015.



(Millions of U.S. Dollars)




## Exports Support Jobs

- Nationally, U.S. jobs supported by exports reached an estimated 11.5 million in 2015, up 1.9 million from 2009.

## Exports Sustain Thousands of Missouri Businesses


- A total of 6,089 companies exported from Missouri locations in 2014.

...and **29%** of known Missouri goods export value







Number of Employees by Country of UBO





## Free Trade Agreements

- The U.S. currently has 14 free trade agreements in force with 20 countries.
- Missouri's exports to U.S. FTA partners totaled \$8.2 billion in 2015.

In 2015, exports to FTA markets accounted for **60%** of Missouri exports



Since 2005, exports from Missouri to FTA markets have grown by **26%**

- St. Louis is the 37th largest metro area reporting goods exports nationwide.
