
New Jersey Depends on World Markets

- Exports from New Jersey helped contribute to the \$2.26 trillion of U.S. goods and services exports in 2015.



New Jersey's Top 5 Export Categories (Millions of U.S. Dollars)




Exports Support Jobs

- Nationally, U.S. jobs supported by exports reached an estimated 11.5 million in 2015, up 1.9 million from 2009.



- A total of 20,647 companies exported from New Jersey locations in 2014.



Number of Employees by Country of UBO





Free Trade Agreements

- The U.S. currently has 14 free trade agreements in force with 20 countries.
- New Jersey's exports to U.S. FTA partners totaled \$13.4 billion in 2015.

In 2015, exports to FTA markets accounted for **42%** of New Jersey exports



Since 2005, exports from New Jersey to FTA markets have grown by **64%**

New Jersey's Metropolitan Exports

- New York-Newark-Jersey City is the 2nd largest metro area reporting goods exports nationwide.
