
## Nevada Depends on World Markets

- Exports from Nevada helped contribute to the \$2.26 trillion of U.S. goods and services exports in 2015.



Nevada's Top 5 Export Categories (Millions of U.S. Dollars)




## Exports Support Jobs

- Nationally, U.S. jobs supported by exports reached an estimated 11.5 million in 2015, up 1.9 million from 2009.

## Exports Sustain Thousands of Nevada Businesses



- A total of 3,104 companies exported from Nevada locations in 2014.


# Nevada Exports, Jobs, & Foreign Investment

Number of Employees by Country of UBO





## Free Trade Agreements


- The U.S. currently has 14 free trade agreements in force with 20 countries.
- Nevada's exports to U.S. FTA partners totaled \$2.3 billion in 2015.

In 2015, exports to FTA markets accounted for **26%** of Nevada exports



Since 2005, exports from Nevada to FTA markets have grown by **114%**

## Nevada's Metropolitan Exports

- Las Vegas-Henderson-Paradise is the 79th largest metro area reporting goods exports nationwide.

Metro Area	2015 Goods Export Value	Share of State Exports
Las Vegas-Henderson-Paradise	\$2.9 billion	29.7%
Reno	\$1.9 billion	19.8%
Carson City	\$119 million	1.2%
