
## Utah Depends on World Markets

- Exports from Utah helped contribute to the \$2.26 trillion of U.S. goods and services exports in 2015.



(Millions of U.S. Dollars)




## Exports Support Jobs

- Nationally, U.S. jobs supported by exports reached an estimated 11.5 million in 2015, up 1.9 million from 2009.

## Exports Sustain Thousands of Utah Businesses



- A total of 3,544 companies exported from Utah locations in 2014.

...and **34%** of known Utah goods export value







Number of Employees by Country of UBO





## Free Trade Agreements


- The U.S. currently has 14 free trade agreements in force with 20 countries.
- Utah's exports to U.S. FTA partners totaled \$3.5 billion in 2015.

In 2015, exports to FTA markets accounted for **26%** of Utah exports



Since 2005, exports from Utah to FTA markets have grown by **161%**

## Utah's Metropolitan Exports

- Salt Lake City is the 27th largest metro area reporting goods exports nationwide.

Metro Area	2015 Goods Export Value	Share of State Exports
Salt Lake City	\$10.4 billion	69.5%
Provo-Orem	\$2.2 billion	14.8%
Ogden-Clearfield	\$1.4 billion	9.5%
Logan	\$453 million	*
St. George	\$42 million	0.3%
