

Commerce Initiates Antidumping Duty Investigations of Tin Mill Products from Canada, the People's Republic of China, Germany, the Republic of Korea, the Netherlands, Taiwan, the Republic of Turkey, and the United Kingdom, and a Countervailing Duty Investigation of Tin Mill Products from the People's Republic of China

On February 8, 2023, the U.S. Department of Commerce (Commerce) announced the initiation of antidumping duty (AD) investigations of tin mill products from Canada, the People's Republic of China (China), Germany, the Republic of Korea (Korea), the Netherlands, Taiwan, the Republic of Turkey (Turkey), and the United Kingdom, and a countervailing duty (CVD) investigation of tin mill products from China.
