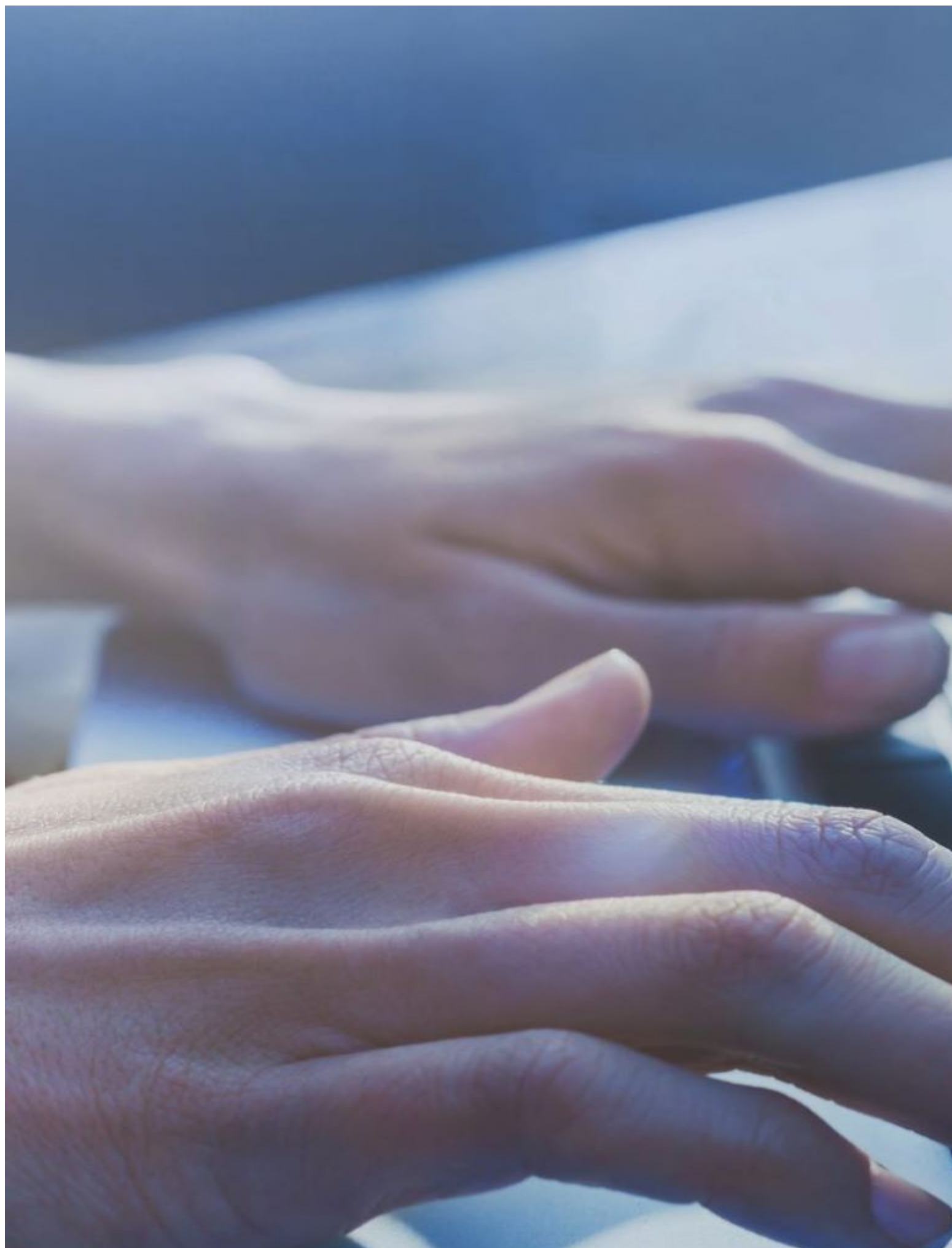

Initiation of AD and CVD investigations of Certain Pea Protein from China

Commerce Initiates Antidumping and Countervailing Duty Investigations of Certain Pea Protein from the People’s Republic of China

On August 2, 2023, the U.S. Department of Commerce (Commerce) announced the initiation of antidumping duty (AD) and countervailing duty (CVD) investigations of certain pea protein from the People’s Republic of China.

Alleged Dumping Margins

* If the International Trade Commission (ITC) makes a negative preliminary determination of injury, then the corresponding AD/CVD investigation(s) will be terminated.

** This will take place only in the event of a final affirmative determination from Commerce.
