Final Affirmative Determinations in the Antidumping Duty Investigations of Paper File Folders from the People's Republic of China, India, and the Socialist Republic of Vietnam

On October 2, 2023, the Department of Commerce (Commerce) announced its affirmative final determinations in the antidumping duty (AD) investigations of paper file folders from the People's Republic of China, India, and the Socialist Republic of Vietnam.
