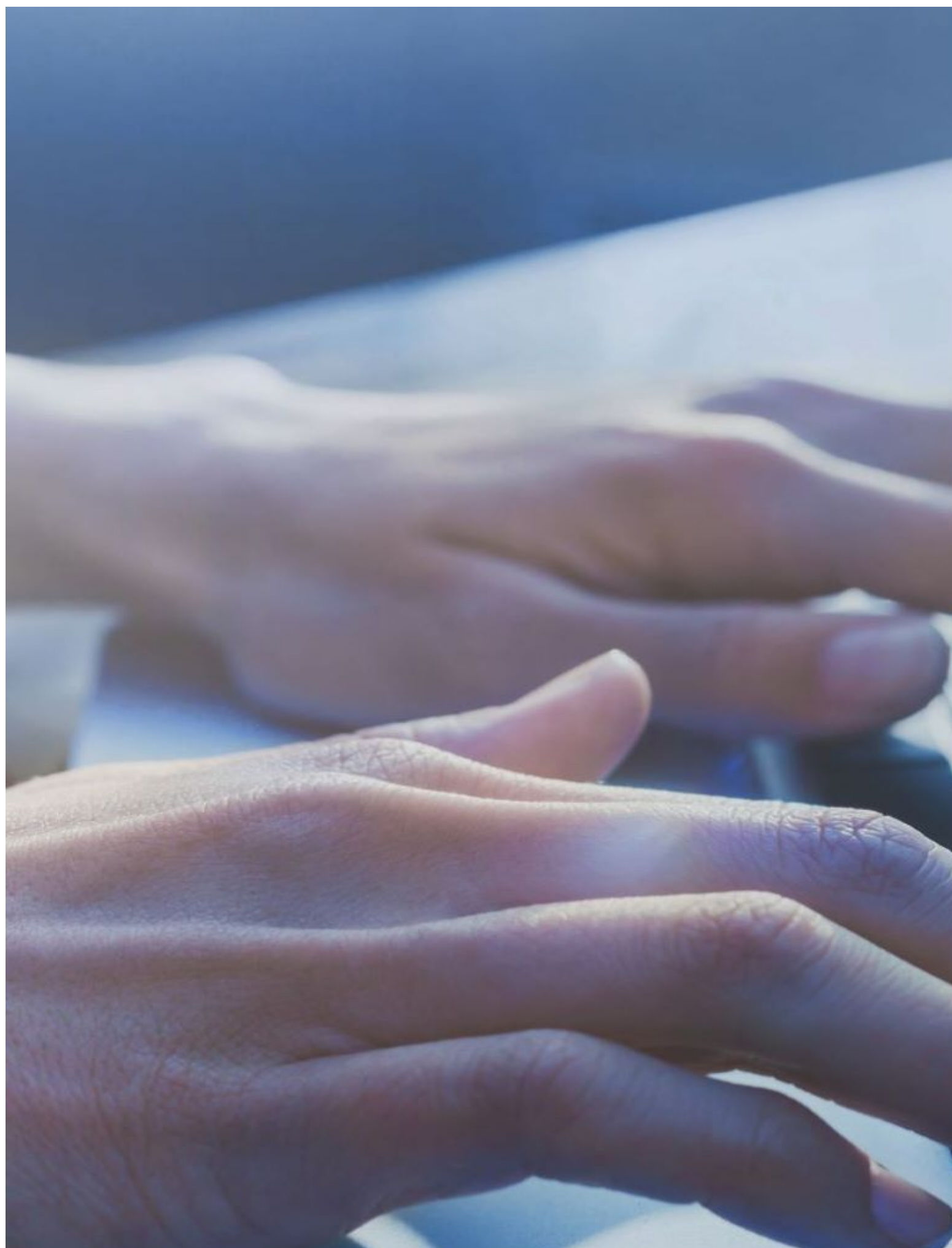

Final Determinations in the AD and CVD Investigations of Gas-Powered Pressure Washers from China

Final Affirmative Determinations in the Antidumping and Countervailing Duty Investigations of Gas-Powered Pressure Washers from the People's Republic of China

On December 19, 2023, the Department of Commerce (Commerce) announced its affirmative final determinations in the antidumping and countervailing duty (AD/CVD) investigations of gas-powered pressure washers from the People's Republic of China (China).
