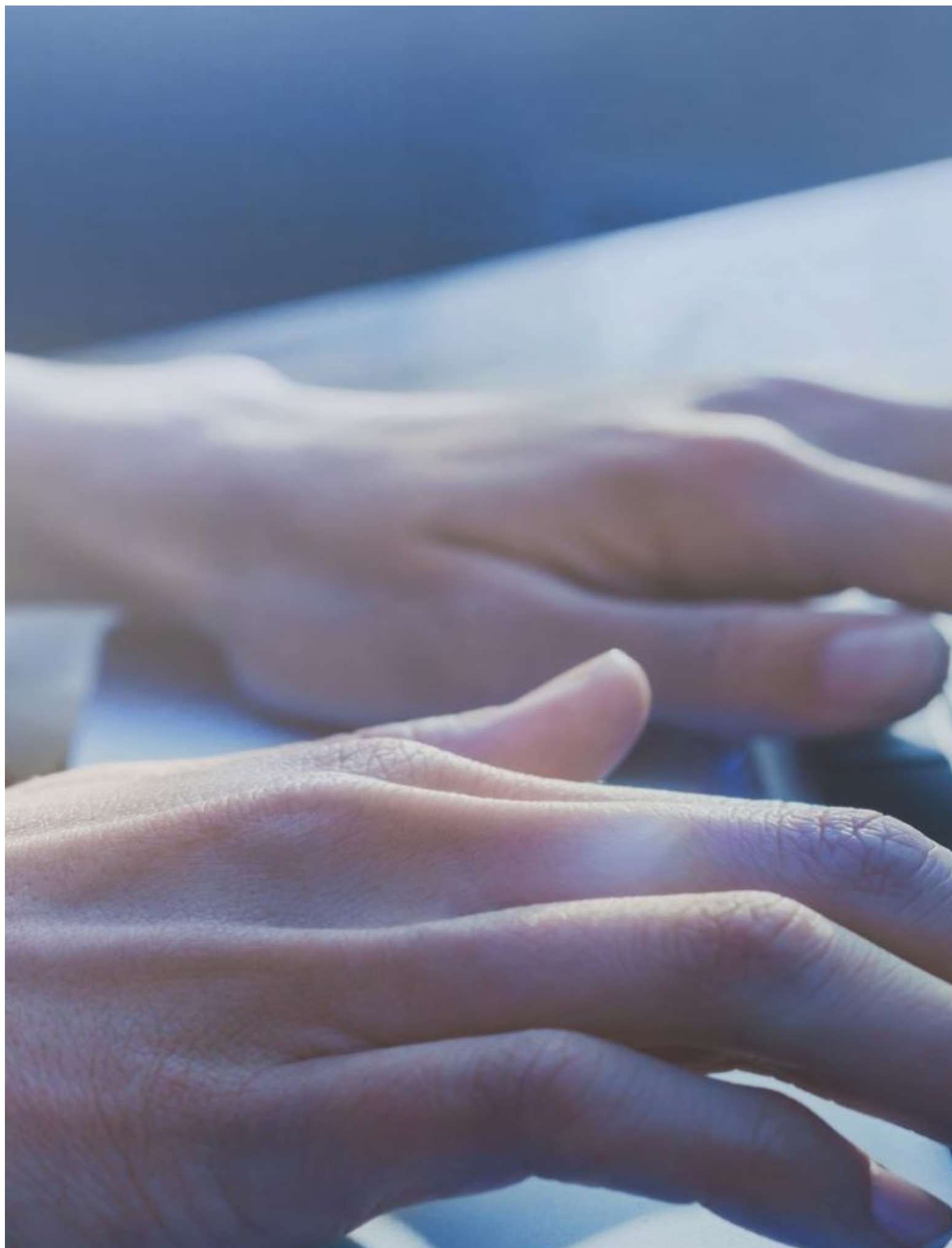

Preliminary Determinations in the AD Investigations of Mattresses from 12 Countries

Preliminary Affirmative Determinations in the Antidumping Duty (AD) Investigations of Mattresses from Bosnia and Herzegovina, Bulgaria, Burma, India, Italy, Kosovo, Mexico, the Philippines, Poland, Slovenia, Spain, and Taiwan

On February 26, Commerce announced affirmative preliminary determinations in the AD investigations of mattresses from Bosnia and Herzegovina, Bulgaria, Burma, India, Italy, Kosovo, Mexico, the Philippines, Poland, Slovenia, Spain, and Taiwan. Commerce is conducting a concurrent [countervailing duty investigation](#) on imports of mattresses from Indonesia.
