## Preliminary Determination in the Antidumping Duty (AD) Investigation of Truck and Bus Tires from Thailand

On May 15, 2024, the U.S. Department of Commerce (Commerce) announced its preliminary determination in the antidumping duty (AD) investigation of truck and bus tires from Thailand.
