

# Final Affirmative Determinations in the Antidumping and Countervailing Duty Investigations of Certain Pea Protein from the People's Republic of China

On June 28, 2024, the U.S. Department of Commerce (Commerce) announced the final affirmative determinations in the antidumping duty (AD) and countervailing duty (CVD) investigations of certain pea protein from the People's Republic of China (China).
