# **Commerce Initiates Antidumping Duty Investigation of Large Top Mount Combination Refrigerator-Freezers from the Thailand**

On July 10, 2024, the U.S. Department of Commerce (Commerce) announced the initiation of an antidumping duty (AD) investigation of large top mount combination refrigerator-freezers from Thailand.
