# Preliminary Affirmative Determination in the Antidumping Duty Investigation of Vanillin from the People's Republic of China

On January 10, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the antidumping duty (AD) investigation of vanillin from the People's Republic of China (China). Commerce is also conducting a <u>concurrent countervailing duty (CVD) investigation</u> of vanillin from China.
