Preliminary Determinations in the AD Investigations of Brake Drums from China and Turkiye

Preliminary Affirmative Determinations in the Antidumping Duty Investigations of Certain Brake Drums from the People's Republic of China and the Republic of Türkiye

On January 24, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determinations in the antidumping duty (AD) investigations of certain brake drums from the People's Republic of China (China) and the Republic of Türkiye (Türkiye). Commerce is also conducting concurrent countervailing duty (CVD) investigations of brake drums from China and Türkiye.
