



Final Affirmative Determinations in the Antidumping Duty Investigations of Epoxy Resins from the People's Republic of China, India, the Republic of Korea, Taiwan, and Thailand and the Countervailing Duty Investigations of Epoxy Resins from People's Republic of China, India, the Republic of Korea, and Taiwan.

On March 31, 2025, the U.S. Department of Commerce (Commerce) announced its final affirmative determinations in the antidumping duty (AD) investigations of epoxy resins from People's Republic of China (China), India, the Republic of Korea (Korea), Taiwan, and Thailand, and the countervailing duty (CVD) investigations of epoxy resins from China, India, Korea, and Taiwan.
