Preliminary Determinations in the Countervailing Duty Investigations of Overhead Door Counterbalance Torsion Springs from China and India

Preliminary Affirmative Determinations in the Countervailing Duty Investigations of Overhead Door Counterbalance Torsion Springs from the People's Republic of China and India

On March 31, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determinations in the countervailing duty (CVD) investigations of overhead door counterbalance torsion springs from the People's Republic of China (China) and India. Commerce is also conducting [concurrent antidumping duty \(AD\) investigations](#) of overhead door counterbalance torsion springs from China and India.
