On May 19, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the countervailing duty (CVD) investigation of sol gel alumina-based ceramic abrasive grains from the People's Republic of China (China). Commerce is also conducting a concurrent antidumping duty (AD) investigation of sol gel alumina-based ceramic abrasive grains from China.
