

Preliminary Affirmative Determination in the Antidumping Duty Investigation of Sol Gel Alumina-Based Ceramic Abrasive Grains from the People's Republic of China

On May 28, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the antidumping duty (AD) investigation of sol gel alumina-based ceramic abrasive grains from the People's Republic of China (China). Commerce is also conducting a concurrent countervailing duty (CVD) investigation of [sol gel alumina-based ceramic abrasive grains from China](#).
