Final Affirmative Determinations in the Antidumping and Countervailing Duty Investigations of Certain Brake Drums from the People’s Republic of China and the Republic of Türkiye

On June 16, 2025, the U.S. Department of Commerce (Commerce) announced its final affirmative determinations in the antidumping and countervailing duty (AD/CVD) investigations of certain brake drums from the People’s Republic of China (China) and the Republic of Türkiye (Türkiye).
