Final Affirmative Determinations in the Antidumping and Countervailing Duty Investigations of Low-Speed Personal Transportation Vehicles from the People’s Republic of China

On June 17, 2025, the U.S. Department of Commerce (Commerce) announced its final affirmative determinations in the antidumping and countervailing duty (AD/CVD) investigations of low-speed personal transportation vehicles from the People’s Republic of China (China).
