## Commerce Initiates Antidumping Duty and Countervailing Duty Investigations of Steel Concrete Reinforcing Bar from Algeria, Bulgaria, Egypt, and the Socialist Republic of Vietnam

On June 25, 2025, the U.S. Department of Commerce (Commerce) announced the initiation of antidumping duty (AD) and countervailing duty (CVD) investigations of steel concrete reinforcing bar (rebar) from Algeria, Bulgaria, Egypt, and the Socialist Republic of Vietnam (Vietnam) and countervailing duty (CVD) investigations of rebar from Algeria, Egypt, and Vietnam.
