Final Affirmative Determinations in the Antidumping and Countervailing Duty Investigations of Certain Tungsten Shot from the People's Republic of China

On July 8, 2025, the U.S. Department of Commerce (Commerce) announced its final affirmative determinations in the antidumping duty (AD) and countervailing duty (CVD) investigations of certain tungsten shot (tungsten shot) from the People's Republic of China (China).
