Preliminary Affirmative Determination in the Antidumping Duty Investigation of Erythritol from the People's Republic of China

On July 14, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the antidumping duty (AD) investigation of erythritol from the People's Republic of China (China). Commerce is also conducting <u>concurrent countervailing duty (CVD) investigations</u> of erythritol from China.
