Final Affirmative Determinations in the Antidumping Duty and Countervailing Duty Investigations of Hexamethylenetetramine from the People's Republic of China

On July 15, 2025, the U.S. Department of Commerce (Commerce) announced its final affirmative determinations in the antidumping duty (AD) and countervailing duty (CVD) investigations of hexamethylenetetramine (hexamine) from the People's Republic of China (China).
