Preliminary Affirmative Determination in the Countervailing Duty Investigation of Polypropylene Corrugated Boxes from the People’s Republic of China

On August 18, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the countervailing duty (CVD) investigation of polypropylene corrugated boxes from the People’s Republic of China (China).
