## Preliminary Affirmative Determination in the Countervailing Duty Investigation of Monomers and Oligomers from Taiwan

On August 26, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the countervailing duty (CVD) investigation of monomers and oligomers from Taiwan
