# Final Affirmative Determinations in the Antidumping Duty and Countervailing Duty Investigations of Slag Pots from the People's Republic of China

On August 26, 2025, the U.S. Department of Commerce (Commerce) announced its final affirmative determination in the antidumping duty (AD) and countervailing duty (CVD) investigation of slag pots from the People's Republic of China
