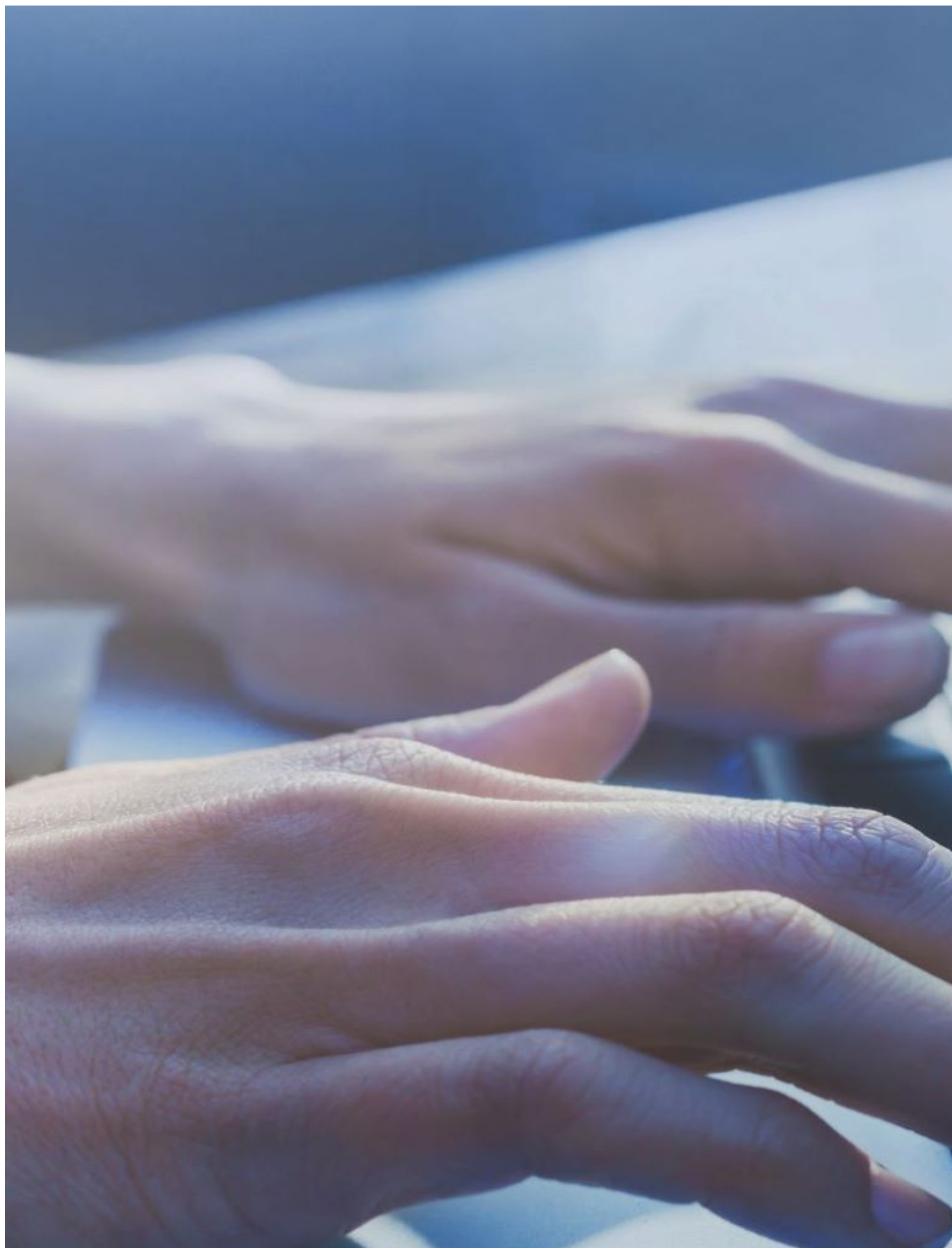

Preliminary Affirmative Determination in the Antidumping Duty Investigation of Methylene Diphenyl Diisocyanate from the People’s Republic of China

On September 11, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determination in the antidumping duty (AD) investigation of methylene diphenyl diisocyanate from the People’s Republic of China (China).
