# Preliminary Affirmative Determination in the Countervailing Duty Investigations of Silicon Metal from Australia, Lao People's Democratic Republic, Norway and Thailand

On September 23, 2025, the U.S. Department of Commerce (Commerce) announced its preliminary affirmative determinations in the countervailing duty (CVD) investigations of silicon metal from Australia, Lao People's Democratic Republic (Laos), Norway, and Thailand

### **Next Steps**

- Unless postponed, the final determinations in these CVD investigations are currently scheduled to be issued on the following dates: December 8, 2025, for Thailand; December 15, 2025, for Laos; and February 3, 2026, for Australia and Norway.
- Commerce is also conducting a <u>concurrent antidumping duty investigation</u> of silicon metal from Angola, Australia, Laos, Malaysia, and Norway
