the committee and basically I want to thank everybody who had the

opportunity to take a look at the draft. We got a number of comments.

We have incorporated a number of them into the letter. I hope everyone got

the final draft last evening from Brian. Where we could we tried to

incorporate as much as we could but try to keep the same tone and the same

purpose for the letter. What I would like to do is ask anyone who has any

further comments on the letter or any questions to please raise them.

The operator will let you know how you can signify to ask a question. When

you ask a question, if you would please identify yourself so we know where

it's coming from and we can have whatever discussion we need to have with

respect to the letter so operator if you could let them know how they can be

able to comment?

Olga Ramudo: Hi. Just a couple of suggestions. On the first line of the letter where we say I

am proud to advise, a suggestion would be I am proud to share that we stand

ready to serve, that's just grammatical, that's no big deal but then in the first

paragraph also where we say the positive impact on the business and jobs in

our sector, I would add there which amount to this many jobs with an

economic impact of this much. Those are my two suggestions.

John Sprouls:

Okay, thank you.

George Aguel:

Hey, John this is George Aguel in Orlando.

John Sprouls:

Hey, George.

George Aguel:

Mine is maybe not relevant, just looking down towards the bottom of the first page, and this may be a given that someone else on this staff is interpreting this and maybe it does or doesn't need it. We refer to the Number 1 item coming-up on the calendar as IPW which in itself can stay, you know, innocuous if we wanted to.

But it just made me wonder if the Secretary is the actual guy reading this is understanding what a wholesale buyer is or something to that effect. It seemed like a description of IPW perhaps something to the effect something like the premier worldwide industry trade show that brings international travel buyers from around the world, something to that effect might add a little more of an explanatory component to it.

I say that saying that maybe they don't need to understand what IPW really means or is and maybe it's not required but it just seemed like it falls, I'm not sure wholesale for example means something to him except in the world of wholesalers and the rules. Just a thought.

John Sprouls:

Yes, thanks, George. I think we're counting on Brian and (Isabel) to fill-in the blanks for him with respect to what specifically it means and to make sure he understands how big a deal IPW is.

Got it, great.

Mike Gallagher: Hey John, this is Mike Gallagher.

John Sprouls: Hey, Mike.

Mike Gallagher: Hey. I'm sure we are doing this but just to double-check. We are inviting him

to come and see IPW aren't we, or they're going to do that?

John Sprouls: Yes, U.S. Travel is doing that, Mike.

Mike Gallagher: Okay, thank you.

Bruce Charendoff: Hey John, it's Bruce Charendoff from Saber. On the top of two of Page 2, the

use of the quoted phrase "open for business" of course it'd be wonderful for him to deliver a message like that but open for business was the catch line of the Obama administration and Penny Pritzker and I just kind of wonder if we should be quoting them or to use it some different phraseology that makes it

clear that we understand that this is a new administration and a new day.

So you know, we could just say something that the United States absolutely

welcomes legitimate business and leisure travelers, something along those

lines that shows our sensitivity to that.

John Sprouls: Yes, I think that would work. I think that's okay. I mean, I just like open for

business because it kind of works.

Bruce Charendoff: Yes

John Sprouls: Yes, but I think you could do that. I get the sensitivity. Absolutely the

message that the United States is absolutely welcoming to legitimate business

and leisure travelers, is that what you're saying?

Bruce Charendoff: Yes, that's ...

John Sprouls: Welcoming?

Bruce Charendoff:...yes.

John Sprouls: Okay. Brian, (Isabel)?

Brian Beall: Yes.

(Isabel): Yes.

John Sprouls: Olga's comment about the size of the sector, do we need that in this letter or

does he have that information? Does he know?

(Isabel): He has it. I don't think it's given the amount of material he gets on a regular

basis, I think it's always good to include it so we're happy to do that and

similarly with the ...

Bruce Charendoff: And it's also in the bottom of the first paragraph on the second page. We talk

about internationally, the second largest export, millions of American jobs

depending upon it, yes, so I think we've got it there.

(Isabel): Yes, we can put in the actual figures if you'd like.

Ted Balestreri: This is Ted, Ted Balestreri, Cannery Row Company. I set the letter up. I know

our original goal which I think he should be excited about is to get to 100 million people by 2021 and if we could give him an overview of what that impact would do but the 30 additional million people all boats would rise,

jobs, it's the cleanest industry for the environment, it helps the most needy in

our country with upward mobility.

It has all the benefits that are on top of the list of which this administration

would be very excited about and that's what all these efforts put together is

that's what our goal is to achieve and if he could understand that, I think that's

a very big plus.

John Sprouls:

Yes, I totally agree with you Ted and in fact that's what we're hoping comes-

out of the new subcommittee that that level of both detail and

recommendation for him that we will hopefully sign-off on at our June 5th

meeting, you know, and then deliver that to him in terms of a series of

recommendations that would talk about exactly those issues.

We were trying to keep this letter short because we just wanted him to focus

on he and the administration have got to try to clarify for the rest of the world

that in terms of welcoming legitimate leisure and business travelers, we don't

want people to be confused that the U.S. is - I won't use the phrase in the

letter - but we're open for business.

Ted Balestreri:

No, but I would say this too and to achieve that goal to bring tourists in from

friendly nations of, you know, something to not get them nervous that we

want to open-up the floodgates.

John Sprouls:

Yes, I think that's why we called them in a couple of places legitimate

travelers.

Ted Balestreri:

Or legitimate traveler-friendly nations but I think the whole essence of the

whole thing is that's it, bring in those 30 million people.

John Sprouls:

Yes. That is the job.

Ted Balestreri: Tha

That's the job we're there for.

John Sprouls:

Okay. Any other comments that we hadn't picked-up? If that's the case I am going to ask for a motion from someone on the committee to approve the letter so that we can send it off to the Secretary with the change in the paragraph on the top of Page 2, the change "open for business" to the word welcoming.

Isabel:

And John also are you looking for the clarification that of IPW being an international trade show, bringing international buyers in?

John Sprouls:

No, I would leave the letter as it is. I would just rely on you guys to make the Secretary aware, oh, I'm sorry, go ahead, (Jim).

(Jim):

(Isabel) was going to give you specific facts and figures for that last ...

John Sprouls:

Okay, I'm sorry, yes, so there would be two changes to the paragraph at the top of Page 2. One is adding the word welcoming and then in the last sentence, (Isabel) you will change millions of Americans' jobs to cite the specific number of jobs?

(Isabel):

Yes.

John Sprouls:

Okay so with those two changes, I would entertain a motion to approve this letter so we can send it to the Secretary.

Brian Beall:

And John this is Brian, I'm sorry to interrupt you for one second. On the agenda we had the public comment before the board vote. Would you like to proceed?

John Sprouls: Oh, I'm sorry.

Brian Beall: Would you like to open it up ...

John Sprouls: I'm sorry, I apologize.

Brian Beall: ...that's okay. If that works for you, we could open it up. Let's see, I think we

only had two people from the public register to participate so at this time if that works for you John we could allow them to offer any comments that

they'd like and then proceed to the board for ...

John Sprouls: Absolutely, let's open it for public comment.
