 - U.S. EXIM Bank recently received a 7-year extension.
 - U.S. Development Finance Corporation (DFC) established on October 1. DFC currently maintains OPIC's ban on financing new nuclear projects.
 - World Bank prohibition on financing nuclear projects still in place.
 - No update on President's Nuclear Fuel Working Group (NFWG) Report was originally intended to be submitted in October.
