# Foreign- Trade Zones Board

## U.S. FOREIGN-TRADE ZONES

Foreign-trade zones are secure areas under U.S. Customs supervision that are considered outside the Customs territory of the United States for the purposes of Customs duty payment upon activation under the regulations of the U.S. Customs Service. Located in or near U.S. Customs ports of entry, they are the U.S. version of what are known internationally as free trade zones. Authority for establishing these facilities is granted by the Foreign-Trade Zones Board under the Foreign-Trade Zones Act of 1934, as amended (19 U.S.C. 81a-81u), and the Board's regulations (15 C.F.R. Part 400). The Executive Secretariat of the Board is located within the Import Administration of the U.S. Department of Commerce, Washington, D.C. 20230.

Foreign and domestic merchandise may, subject to FTZ Board and Customs regulations, be moved into zones for operations not otherwise prohibited by law involving storage, exhibition, assembly, manufacturing, and processing. All zone activity is subject to public interest review, and all manufacturing and processing activity requires a case-by-case review. Under zone procedures the usual formal Customs entry procedure and payment of duties is not required on the foreign merchandise unless and until it enters Customs territory for domestic consumption, in which case the importer normally has a choice of paying duties either on the original foreign materials or the finished product. Domestic goods moved into a zone for export are considered exported upon entering the zone for purposes of excise tax rebates and drawback. FTZ sites and activities remain within the jurisdiction of federal, state and local governments and agencies.

Zones are sponsored by qualified public or public-type corporations, which may themselves operate the facilities or contract for their operations with public or private firms. The operations are conducted on a public utility basis, with published rates. A typical general-purpose zone provides leasable storage/distribution space to users in general warehouse type buildings with access to all modes of transportation. Most zone projects include an industrial park site with lots on which zone users can construct their own facilities. Subzones are usually private plant sites authorized by the Board through zone grantees for operations that cannot be accommodated within an existing general-purpose zone.

The regulations of the Foreign-Trade Zones Board are published in the Code of Federal Regulations at Title 15, Part 400 (15 C.F.R. Part 400), and the regulations of the U.S. Customs Service concerning zones at Title 19, Part 146 (19 C.F.R. Part 146). \* Agreements pursuant to Article XXIV of the GATT to reduce Customs tariffs and restrictions on trade between the member countries establish what are known as "free-trade areas" (e.g., the North American Free-Trade Area).

## REPORT OF THE EXECUTIVE SECRETARY

During fiscal 2000, the Foreign-Trade Zones (FTZ) Board issued 60 formal orders. The decisions included approvals for 5 new general-purpose zones and 22 new subzones. Authority was also granted for the expansion of 16 existing general-purpose zones and 3 subzones. Other actions involved the granting of authority for revisions to zone plans, as well as approvals for new manufacturing activity.<sup>1</sup> At the same time, 6 applications were withdrawn by the applicants and 1 application was denied.

The number of approved zones declined despite the approval of 5 new zones because six zones were removed from the list of approved projects based on the lapse provision of the FTZ regulations. (The lapsed zones are FTZ Nos. 91, 97, 178, 190, 192 and 194.)

There were 144 FTZ projects fully active during the year, with subzones in operation in over 88 of them. The number of facilities using subzone status increased to 217, with 18 new ones initiating the use of FTZ procedures and 11 discontinuing.

The combined value of shipments into general-purpose zones and subzones totaled \$238 billion compared to \$174 billion last year (Figure 1 and Appendix D). General-purpose sites received \$28 billion in merchandise. Total shipments received at subzone sites amounted to \$210 billion. Some 88 percent of zone activity took place at subzone facilities, which is consistent with the pattern of the past 15 years.<sup>2</sup>

<sup>1</sup> Appendix A contains a list with a summary of each Board Order. Zone authority for manufacturing/processing activity was granted on a restricted basis in 15 cases, and activation limits were adopted in another 12. The main products covered by restrictions included crude oil, steel, chemicals, pneumatic components and textile products.

<sup>2</sup> Appendices B and C contain figures on shipments into and out of general-purpose zones and subzones. Appendix D contains comparative statistics for the past 5 years. The figures represent the latest statistical data available from grantees. Some are still under review. Adjustments normally amount to less than one percent of aggregate shipments and would be reflected in next year's report.

Over 340,000 persons were employed at some 2,420 firms that operated under FTZ status during the year. The main foreign-origin products received at zones are listed in Appendix E.

Industry sectors that continued to account for most zone manufacturing activity were oil refining, auto, other motor vehicle, computer/office equipment and metal producing firms. An estimated 64 percent of the shipments received at zones for use in manufacturing activity involved domestic status merchandise. The level of domestic status inputs used by such FTZ operations indicates that FTZ activity tends to involve domestic operations that combine foreign inputs with significant domestic inputs. This reflects the fact that FTZ procedures serve as a means of rationalizing Customs treatment to assist domestic plants in their efforts to be internationally competitive.

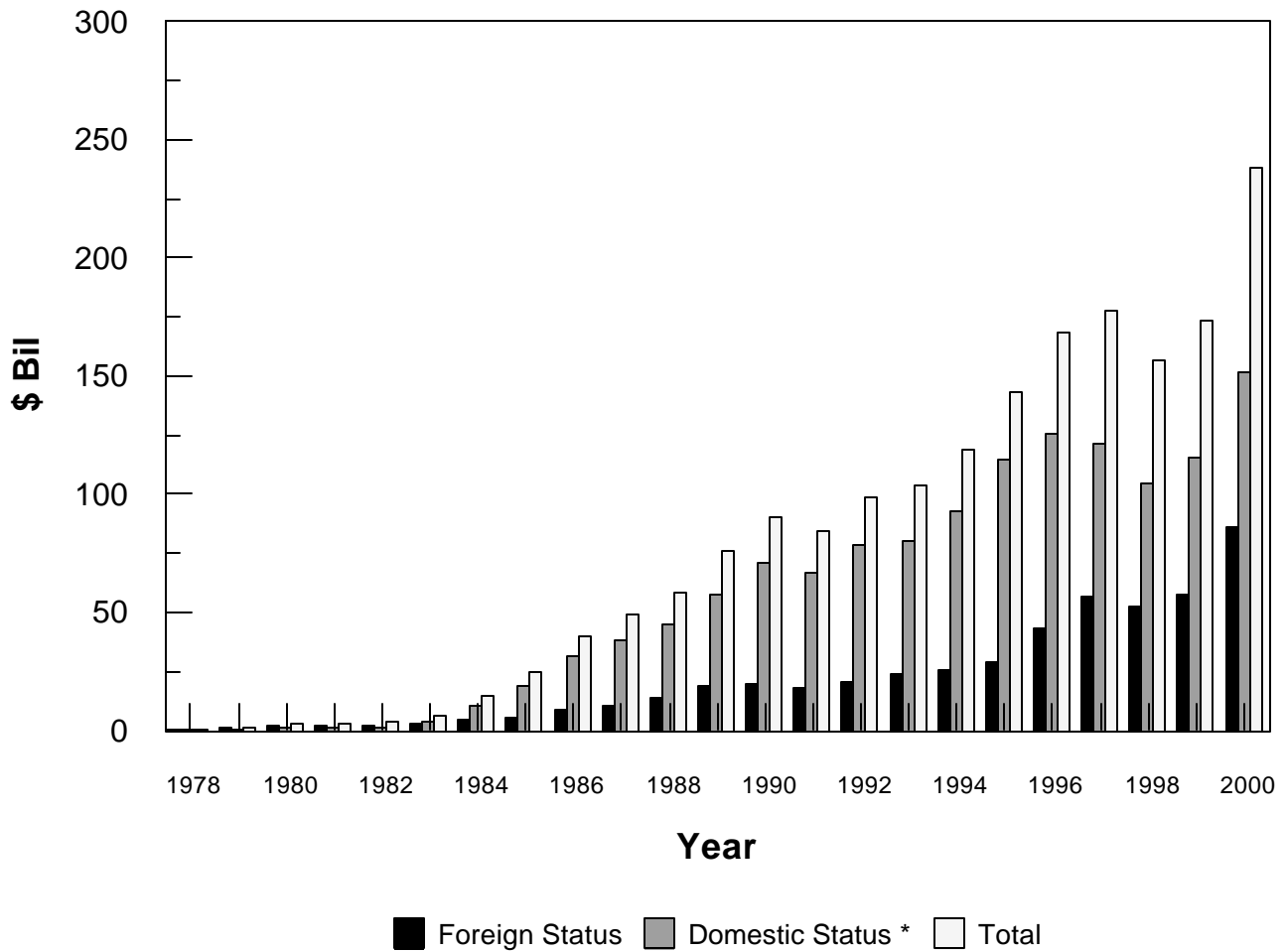
The Board received and filed 75 formal applications during the fiscal year. These proposals requested authority for 8 new general-purpose zones and 23 subzones, as well as authorization for expansion and new manufacturing at existing zone projects (Appendix F). In addition, over 75 cases were processed under the Board's less formal administrative procedures (Appendix G). The latter cases involved routine, non-controversial changes to zone projects such as boundary modifications and scope decisions. Some proposals were processed under the Board's "fast track" procedure, which is used when there are recent precedents for the contemplated activity or when only exports are involved.

Last year, exports (shipments to foreign countries) from facilities operating under FTZ procedures amounted to \$15 billion (Figure 2). The export figure for FY 2000 was lower than that for the previous year primarily because of a special change in Customs procedures for handling export activity related to space launches. Though the activity continued, FTZ procedures were no longer needed because merchandise related to this activity became duty-free. The export figures do not include indirect exports involving FTZ merchandise which undergoes further processing in the U.S. at non-FTZ sites prior to export.

(general-purpose zones and subzones)



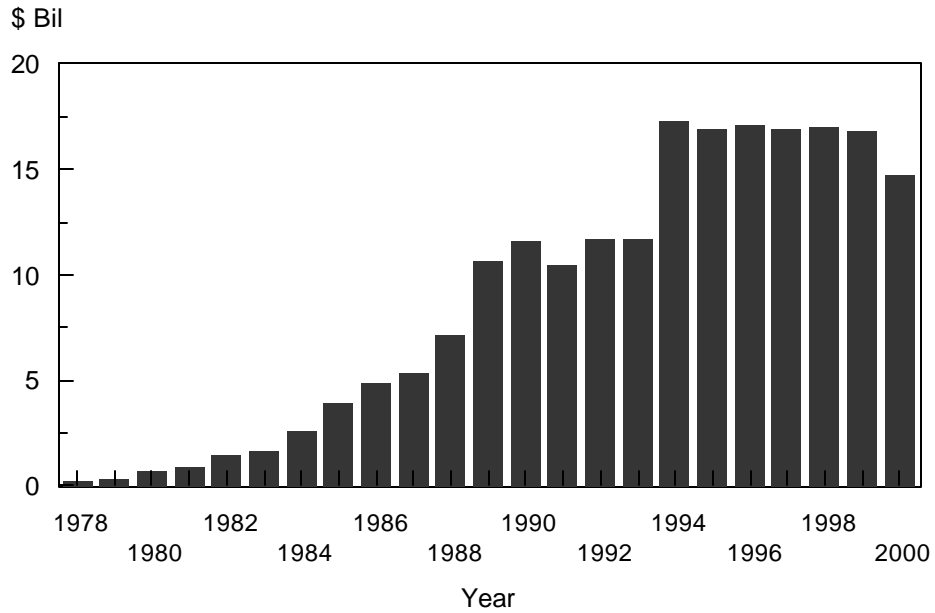

## Glossary of Terms

**Admit, Admission** are the Customs terms describing the shipment of merchandise into U.S. foreign-trade zones under Customs supervision (19 CFR 146.1).

**Board** means the Foreign-Trade Zones Board, which consists of the Secretary of the Department of Commerce (chair) and the Secretary of the Treasury, or their designated alternates.

**Customs** means the United States Customs Service of the Department of the Treasury.

**Domestic origin/duty paid** describes zone merchandise that is mainly of domestic origin but also includes foreign-origin merchandise on which Customs entry and duty payments have been made prior to admission to the zone site.

**Domestic status** (also, **Domestic status inputs**) - Used synonymously with **Domestic origin/duty paid** (see above). Domestic status is the Customs status (19 CFR § 146.43) for domestic origin and duty paid foreign origin zone merchandise.

**Entry for Consumption** is the term that describes the general Customs process of filing the appropriate Customs documents that allows merchandise to be brought into the commerce of the U.S. (19 CFR 141). With respect to foreign-trade zones, this process occurs when merchandise is shipped from the zone into U.S. commerce.

**Exports** describes the category of merchandise that is forwarded from zone sites to destinations in foreign countries.

**Foreign-trade zone** is a restricted-access site, in or adjacent to a Customs port of entry, operated pursuant to public utility principles under the sponsorship of a corporation granted authority by the Board pursuant to the Foreign-Trade Zones Act (19 USC 81a-81u) and regulations (15 CFR Part 400), and under supervision of the Customs Service.

**Foreign status** (also, **Foreign status inputs**) describes zone merchandise admitted to a zone site under Customs supervision that is normally of foreign origin. Such merchandise is admitted to zone sites without being subject to formal Customs entry procedures and payment of duties, unless and until the foreign merchandise enters Customs territory for domestic consumption. Foreign status merchandise is further categorized by Customs as either **Non-Privileged Foreign** or **Privileged Foreign**.

**Forwarded** (also, **Shipped**) describes the category of merchandise that is shipped from or forwarded from zone sites after release by Customs. This category includes merchandise that is forwarded to destinations in the U.S. market as well as merchandise that is exported--that is, forwarded to markets in foreign countries.



**Grant of authority** is a document issued by the Board which authorizes a zone grantee to establish, operate and maintain a zone project or a subzone, subject to limitations and conditions specified in the Board's regulations (19 CFR Part 400) and in 19 CFR part 146. The authority to establish a zone includes the authority to operate and the responsibility to maintain it.

**Manufacturing** means activity involving the substantial transformation of a foreign article resulting in a new and different article having a different name, character, and use.

**Merchandise received** involves merchandise received into activated FTZ space under FTZ procedures by foreign-trade zones and subzones. It includes foreign status merchandise and domestic status merchandise

**Non-Privileged Foreign Status** is one of two Customs categories of **Foreign Status** merchandise (See 19 CFR 146.42). Such merchandise is evaluated based on its condition at the time it is shipped from the zone to the U.S. market and entered for consumption by Customs.

**Port of entry** means a port of entry in the United States, as defined by part 101 of the regulations of the Customs Service (19 CFR part 101), or a user fee airport authorized under 19 U.S.C. 58b and listed in part 122 of the regulations of the Customs Service (19 CFR part 122).

**Privileged Foreign Status** is one of two Customs categories of **Foreign Status** merchandise (See 19 CFR 146.41). Such merchandise maintains its status based on its condition when it was admitted to the zone. Thus, when the merchandise is shipped from the zone to the U.S. market and entered for consumption by Customs, it is evaluated based on the time-of-admission condition even though it might have undergone a transformation in the zone.

**Processing**, when referring to zone activity, means any activity involving a change in condition of merchandise, other than manufacturing, which results in a change in the Customs classification of an article or in its eligibility for entry for consumption.

**Subzones** are a special-purpose type of ancillary zone authorized by the Board, through grantees of public zones, for operations by individual firms that cannot be accommodated within an existing zone when it can be demonstrated that the activity will result in a significant public benefit and is in the public interest.

**Zone** means a **foreign-trade zone** (see above) established under the provisions of the FTZ Act and regulations. The term also includes subzones, unless the context indicates otherwise.

**Zone grantee** is the corporate recipient of a grant of authority for a zone project. The term "grantee" means "zone grantee" unless otherwise indicated.

**Zone operator** is a corporation, partnership, or person that operates a zone or subzone under the terms of an agreement with the zone grantee or an intermediary entity, with the concurrence of the Port Director of Customs.

**Zone project** means the zone plan, including all of the zone and subzone sites that the Board authorizes a single grantee to establish.
