Vermont's Trade with the World¹

- In 2019, Vermont exported \$3.0 Billion in goods to the world.
- In 2019, Vermont was the 44th-largest state exporter of goods in the United States.
- In 2016, 11,707 U.S. jobs were supported by goods exported from Vermont.²
- In 2018, 1,137 companies exported goods from Vermont- 85 percent were small and mediumsized companies.³

In 2019, Canada was Vermont's largest export destination and Mexico was the thirteenth-largest export destination.

Statewide Statistics and Top Export Product Categories⁴

- In 2019, Vermont exported \$1.2 Billion to Canada and Mexico, accounting for 41 percent of Vermont's total exports to the world.
 - Vermont exported \$1.2 Billion to Canada, 40 percent of Vermont's exports to the world.



USMCA Will Benefit Vermont's Top Export Sectors to Canada and Mexico

Vermont's top export sectors to Canada and Mexico in 2019 include Computer and Electronic Products, Paper and Paper Products, and Food Manufacturing.⁶

Computer and Electronic Products

Vermont is home to many leading technology manufacturing companies.⁷ In 2019, there were 43 computer and electronic product⁸ establishments in Vermont employing 4,728 employees. Chittenden and Washington counties have the largest number of employees in the computer and electronic product sector. USMCA maintains duty-free access to Mexico and Canada for originating technology equipment for Vermont's technology manufacturing companies. Industry⁹ appreciates the Market Access provision to be able to export and import for repair since many products are designed to be modular and swappable in case of malfunction in the technology sector. Industry¹⁰ supports the provision to prohibit unnecessary restrictions on remanufactured imports because the technology sector seeks to prolong the useful life of goods through repair, refurbishment, and reuse. Industry¹¹ acknowledges USMCA's new mechanism in the Information and Communication Technology (ICT) Equipment Annex to protect intellectual property in cryptographic products as a significant achievement. Industry¹² approves the new Digital Trade chapter, which contains the strongest disciplines on digital trade of any international agreement, providing a firm foundation for the expansion of trade and investment in innovative electronic products and services. For the first time in a trade agreement, the Intellectual Property chapter includes protections against the misappropriation of trade secrets and requires a minimum term of protection for industrial designs of at least 15 years.

Paper and Paper Products

Vermont is home to numerous paper and paper product manufacturing.¹³ In 2019, there were 9 paper and paper products¹⁴ establishments employing 683 employees. USMCA maintains duty-free access to Mexico and Canada for originating paper products from Vermont's paper manufacturing companies and contains strong rules of origin protections to ensure that tariff preferences go to companies in the USMCA countries. USMCA also goes beyond any past trade agreement by including new Customs and Trade Facilitation provisions that will help reduce costs and bring greater predictability to the border for

shipments of paper and paper products, while at the same time ensuring customs administrations have the necessary tools to enforce the law. Industry¹⁵ reported their support of the Customs and Trade Facilitations chapter since delays in customs clearance are extremely costly for traders, manufacturers, and retailers. Industry¹⁶ also supports the Environment provisions incorporated in the core of USMCA, which promote sustainable forest management and trade in legally harvested products. Furthermore, the agreement provisions call for Parties to effectively enforce their environmental laws.

Food Manufacturing

Vermont is home to several large food manufacturing companies. ¹⁷ In 2019, there were 226 food manufacturing ¹⁸ establishments with 5,254 employees. Chittenden (Burlington), Franklin, and Washington counties have the largest number of employees. USMCA contains an annex on proprietary food formulas which requires each Party to protect the confidentiality of such information in the same manner for both domestic and imported products. For the first time in a trade agreement, USMCA contains a chapter on good regulatory practices that promotes transparency and accountability in development and implementation of regulations. USMCA also has a chapter on sanitary and phytosanitary (SPS) provisions, which requires the Parties to agree to increase transparency in SPS measures, advance science-based decision making, and work together to enhance compatibility of SPS measures between them.
