The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled million10,115.6 square meter equivalents (MSME) in June 2022, an increase of 18.5 percent compared to June 2021. Imports of textiles were 7,352.3 MSME in June 2022, up 18.4 percent from June 2021. Imports of apparel were 2,763.3 MSME in June 2022, up 19.0 percent from June 2021.

Imports of textiles and apparel were 57,070.1 MSME for the year-to-date June 2022, an increase of 39.4 percent from year-to-date June 2021. Imports of textiles were 40,504.4 MSME for the year-to-date June 2022, an increase of 46.9 percent from the year-to-date June 2021. Apparel imports for the year-to-date June 2022 were 16,565.8 MSME, up 24.0 percent from the year-to-date June 2021.
