The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 10,006.4 million square meter equivalents (MSME) in July 2022, an increase of 12.2 percent compared to July 2021. Imports of textiles were 7,067.7 MSME in July 2022, up 10.2 percent from July 2021. Imports of apparel were 2,938.7 MSME in July 2022, up 17.4 percent from July 2021.

Imports of textiles and apparel were 67,074.7 MSME for the year-to-date July 2022, an increase of 34.5 percent from year-to-date July 2021. Imports of textiles were 47,571.1 MSME for the year-to-date July 2022, an increase of 39.9 percent from the year-to-date July 2021. Apparel imports for the year-to-date July 2022 were 19,503.6 MSME, up 22.9 percent from the year-to-date July 2021.
