The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 9,137.0 million square meter equivalents (MSME) in August 2022, a decrease of 0.6 percent compared to August 2021. Imports of textiles were 6,081.8 MSME in August 2022, down 4.2 percent from August 2021. Imports of apparel were 3,055.3 MSME in August 2022, up 7.6 percent from August 2021.

Imports of textiles and apparel were 76,210.1 MSME for the year-to-date August 2022, an increase of 29.0 percent from year-to-date August 2021. Imports of textiles were 53,651.7 MSME for the year-to-date August 2022, an increase of 33.0 percent from the year-to-date August 2021. Apparel imports for the year-to-date August 2022 were 22,558.4 MSME, up 20.6 percent from the year-to-date August 2021.
