The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,819.0 million square meter equivalents (MSME) in September 2022, an increase of 6.3 percent compared to September 2021. Imports of textiles were 6,137.8 MSME in September 2022, up 13.3 percent from September 2021. Imports of apparel were 2,681.2 MSME in September 2022, down 7.0 percent from September 2021.

Imports of textiles and apparel were 85,027.4 MSME for the year-to-date September 2022, an increase of 26.2 percent from year-to-date September 2021. Imports of textiles were 59,788.8 MSME for the year-to-date September 2022, an increase of 30.6 percent from the year-to-date September 2021. Apparel imports for the year-to-date September 2022 were 25,238.6 MSME, up 16.9 percent from the year-to-date September 2021.
