The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 7,809.3 million square meter equivalents (MSME) in October 2022, a decline of 12.4 percent compared to October 2021. Imports of textiles were 5,598.7 MSME in October 2022, down 7.5 percent from October 2021. Imports of apparel were 2,210.6 MSME in October 2022, down 22.7 percent from October 2021.

Imports of textiles and apparel were 92,835.4 MSME for the year-to-date October 2022, an increase of 21.7 percent from year-to-date October 2021. Imports of textiles were 65,387.4 MSME for the year-to-date October 2022, an increase of 26.2 percent from the year-to-date October 2021. Apparel imports for the year-to-date October 2022 were 27,448.1 MSME, up 12.3 percent from the year-to-date October 2021.
