The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 1,217.0 million square meter equivalents (MSME) in November 2022, a decline of 31.8 percent compared to November 2021. Imports of textiles were 536.0 MSME in November 2022, down 30.5 percent from November 2021. Imports of apparel were 680.9 MSME in November 2022, down 32.8 percent from November 2021.

Imports of textiles and apparel were 19,033.0 MSME for the year-to-date November 2022, a decline of 1.9 percent from year-to-date November 2021. Imports of textiles were 7,391.8 MSME for the year-to-date November 2022, a decline of 9.0 percent from the year-to-date November 2021. Apparel imports for the year-to-date November 2022 were 11,641.2 MSME, up 3.3 percent from the year-to-date November 2021.
