The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 6,153.7 million square meter equivalents (MSME) in December 2022, a decline of 31.6 percent compared to December 2021. Imports of textiles were 4,236.9 MSME in December 2022, down 34.7 percent from December 2021. Imports of apparel were 1,916.7 MSME in December 2022, down 23.8 percent from December 2021.

Imports of textiles and apparel were 105,879.2 MSME for the year ending December 2022, an increase of 12.3 percent from year ending December 2021. Imports of textiles were 74,772.9 MSME for the year ending December 2022, up 15.3 percent from the year ending December 2021. Apparel imports for the year ending December 2022 were 31,106.3 MSME, up 5.5 percent from the year ending December 2021.
