The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 7,140.0 million square meter equivalents (MSME) in March 2023, a decline of 23.8 percent compared to March 2022. Imports of textiles were 5,280.8 MSME in March 2023, down 15.7 percent from March 2022. Imports of apparel were 1,859.2 MSME in March 2023, down 40.1 percent from March 2022.

Imports of textiles and apparel were 19,735.7 MSME for the year-to-date March 2023, a decline of 24.3 percent from year-to-date March 2022. Imports of textiles were 13,909.0 MSME for the year-to-date March 2023, a decline of 21.5 percent from the year-to-date March 2022. Apparel imports for the year-to-date March 2023 were 5,826.7 MSME, down 30.1 percent from the year-to-date March 2022.
