The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 7,896.7 million square meter equivalents (MSME) in April 2023, a decline of 22.7 percent compared to April 2022. Imports of textiles were 6,124.6 MSME in April 2023, down 18.7 percent from April 2022. Imports of apparel were 1,772.1 MSME in April 2023, down 34.1 percent from April 2022.

Imports of textiles and apparel were 27,630.9 MSME for the year-to-date April 2023, a decline of 23.8 percent from year-to-date April 2022. Imports of textiles were 20,033.5 MSME for the year-to-date April 2023, a decline of 20.7 percent from the year-to-date April 2022. Apparel imports for the year-to-date April 2023 were 7,597.4 MSME, down 31.1 percent from the year-to-date April 2022.
