Dear Minister Azcona:

In a May 28, 2004 letter to the Government of Honduras in the context of the United States-Central American-Dominican Republic Free Trade Agreement (Agreement) negotiations, the United States agreed to conduct an investigation to determine whether certain shirting fabrics are available in commercial quantities in a timely manner in the territory of any of the Parties to the Agreement. The United States further agreed to make the results of the investigation available to the Parties before the entry into force of the Agreement.

After a thorough investigation which included reviewing written comments from shirt makers and fabric suppliers, meeting with industry representatives, spending time in manufacturing facilities, and observing and learning about their capabilities, we have concluded that 12 of the 53 fabrics investigated are not available in commercial quantities in a timely manner in the territory of any of the Parties to the Agreement.
