The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,426.9 million square meter equivalents (MSME) in June 2023, a decline of 16.7 percent compared to June 2022. Imports of textiles were 6,377.2 MSME in June 2023, down 13.2 percent from June 2022. Imports of apparel were 2,049.7 MSME in June 2023, down 25.9 percent from June 2022.

Imports of textiles and apparel were 44,844.8 MSME for the year-to-date June 2023, a decline of 21.4 percent from year-to-date June 2022. Imports of textiles were 33,206.7 MSME for the year-to-date June 2023, a decline of 18.0 percent from the year-to-date June 2022. Apparel imports for the year-to-date June 2023 were 11,638.1 MSME, down 29.7 percent from the year-to-date June 2022.
