The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 9,056.8 million square meter equivalents (MSME) in July 2023, a decline of 9.3 percent compared to July 2022. Imports of textiles were 6,661.1 MSME in July 2023, down 5.6 percent from July 2022. Imports of apparel were 2,395.8 MSME in July 2023, down 18.2 percent from July 2022.

Imports of textiles and apparel were 53,896.7 MSME for the year-to-date July 2023, a decline of 19.6 percent from year-to-date July 2022. Imports of textiles were 39,864.3 MSME for the year-to-date July 2023, a decline of 16.2 percent from the year-to-date July 2022. Apparel imports for the year-to-date July 2023 were 14,032.4 MSME, down 28 percent from the year-to-date July 2022.
