The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 6,980.1 million square meter equivalents (MSME) in November 2023, an increase of 1.5 percent compared to November 2022. Imports of textiles were 5,333.1 MSME in November 2023, up 3.5 percent from November 2022. Imports of apparel were 1,647.1 MSME in November 2023, down 4.7 percent from November 2022.

Imports of textiles and apparel were 85,874.6 MSME for the year-to-date November 2023, a decline of 13.8 percent from year-to-date November 2022. Imports of textiles were 63,335.8 MSME for the year-to-date November 2023, a decline of 10.1 percent from the year-to-date November 2022. Apparel imports for the year-to-date November 2023 were 22,538.8 MSME, down 22.7 percent from the year-to-date November 2022.
