The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 6,913.6 million square meter equivalents (MSME) in December 2023, an increase of 12.6 percent compared to December 2022. Imports of textiles were 5,115.5 MSME in December 2023, up 21.2 percent from December 2022. Imports of apparel were 1,798.1 MSME in December 2023, down 6.3 percent from December 2022.

Imports of textiles and apparel were 92,783.4 MSME for the year ending December 2023, a decline of 12.3 percent from year ending December 2022. Imports of textiles were 68,447.4 MSME for the year ending December 2023, down 8.4 percent from the year ending December 2022. Apparel imports for the year ending December 2023 were 24,336.1 MSME, down 21.7 percent from the year ending December 2022.
