The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,321.8 million square meter equivalents (MSME) in April 2025. Imports of textiles were 6,355.7 MSME in April 2025, down 3.1 percent from April 2024. Imports of apparel were 1,966.1 MSME in April 2025, up 11.5 percent from April 2024.

Imports of textiles and apparel were 32,869.1 MSME for the year-to-date April 2025, an increase of 9.3 percent from year-to-date April 2024. Imports of textiles were 24,461.3 MSME for the year-to-date April 2025, an increase of 9.1 percent from the year-to-date April 2024. Apparel imports for the year-to-date April 2025 were 8,407.8 SME, up 9.8 percent from the year-to-date April 2024.
