The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 8,020.1 million square meter equivalents (MSME) in May 2025. Imports of textiles were 6,136.1 MSME in May 2025, down 0.1 percent from May 2024. Imports of apparel were 1,704.0 MSME in May 2025, down 13.2 percent from May 2024.

Imports of textiles and apparel were 40,885.4 MSME for the year-to-date May 2025, an increase of 6.6 percent from year-to-date May 2024. Imports of textiles were 30,774.4 MSME for the year-to-date May 2025, an increase of 7.1 percent from the year-to-date May 2024. Apparel imports for the year-to-date May 2025 were 10,111.0 SME, up 5.1 percent from the year-to-date May 2024.
